**ORDERS BY THE GOVERNOR OF ASSAM**  
**NOTIFICATION**

Dated Dispur, the 31st July, 2014

No. RSS.847/2014/2 : The Governor of Assam is pleased to constitute an One Man Committee headed by Shri Bhaskar Barua, IAS (Retd.) to enquire into the allotment / settlement of the Government land especially the wetlands and water-bodies in Guwahati Metropolitan Area.

The terms of reference of the Committee would be as follows :-

- 1) To identify, if any Government Land especially wetlands and water-bodies have been illegally or irregularly allotted or settled since 2001 in violation of existing Laws, Rules or Government Instructions.
  - 2) To identify the Government authorities or officers responsible for such illegal or irregular allotment / settlement of the Government land.
  - 3) To suggest measures to prevent such illegal / irregular allotment / settlement of Government land especially allotment / settlement of the wetlands and water-bodies in Guwahati Metropolitan areas in future.
  - 4) Any other matter related to the subject matter above as may be decided by the Committee.
- Shri Rajib Prakash Barua, ACS, ADC, Kamrup (Metropolitan) district will be the Secretary to the Committee.

Shri A. K. Barman, ACS, Deputy Secretary to the Government of Assam, Revenue & DM Department would be the Nodal Officer in R&DM Department to assist the Committee.

The Committee will submit its report in 3 months.
